RE: Advise to members - State Administrative Tribunal [SAT] Order – SAT Final Determination against Legal action brought by six applicants

The Management Committee is pleased to inform that State Administrative Tribunal has delivered its final decision on 06/02/23.

State Administrative Tribunal has ordered on 06/02/23, the six applicants [Jeyakody SIVANPATHAKUMAR, Kanagaratnam THANABALASINGAM, Vasanthi SIVANPATHAKUMAR, Sundarakanthy NADESAN, Geetha DEVADAS and Sivapragasam ARULPRAGASAM] to pay the Saiva Maha Sabai the sum of \$10,000 towards the SMS insurer's costs. Please find attached the SAT order.

SMS lawyer has confirmed that SMS Insurer received payment of the costs order (in the amount of \$10,000) on 08/02/23 from Jeyakody SIVANPATHAKUMAR. The repeated and multiple legal actions by these individuals over the past two years have been brought to a conclusion with this ruling.

I once again reiterate my AGM commitment to accommodate the views of each member in the decision making and future activities and request members to talk to Management Committee to resolve any issues rather than going through expensive legal process.
